The application form is retained securely by the Membership Secretary; a photocopy having been sent to the Area Secretary in whose area you live. A Membership Update sheet is produced regularly for Society Officers, giving details of new members (name, address, area, date joined, status) and also includes any alterations to existing membership details.
